Currently, we are looking for accomplished professionals in the areas of Finance & Accounting, Economics and Business Environment, Marketing Management, Strategic Management, Decision Sciences, Operations and Supply Chain Management, Information Technology and Systems, Business Communication, Organizational Behaviour & Human Resource Management and Tourism & Hospitality Management. In addition, the Institute will be pleased to receive applications in other areas like Art and Cultural Management, Digital technology, Entrepreneurship, Innovation & Incubation etc.

The key responsibilities would be to develop and teach curriculum in the respective areas of expertise besides steering research projects, community engagement, incubation etc. Senior colleagues with experience of having served in CFTIs are welcome to engage in the mentoring roles with faculty, students and the staff. Such faculty on adjunct roles shall be expected to participate and engage in Institution building activities as assigned by competent authority from time to time. The candidates should have at least 15 years of relevant teaching and research experience. Initially the engagement will be for a period of 1 year, extendable on year to year basis for a maximum of upto 3 years.
