The scanned copy of Demand Draft must be uploaded along with Technical Bid. The agencies registered under MSME/NSIC are exempted from submission of EMD.

The tender consisting of Two-Bid System (Technical & Financial) (separately) so as to be submitted through Central Public Procurement Portal (CPPP) on or before 05:00 hours on 21.10.2023. IIM Sirmaur will not be responsible for any delay for submission of tenders.

Any query with regards to the tender can be asked through email to purchaseoffice@iimsirmaur.ac.in on or before 20.10.2023 up to 05:00 PM. The bidders are requested not to submit any tender documents/bids through email & speed post/courier which will result in non-acceptance of the tender. The bids received through CPPP i.e. Technical & Financial separately will only be considered for further process of evaluation & procurement.

The received tender bids will be opened on the given date & time. Any corrigendum & change of any kind in schedule, terms & conditions, if any, shall be intimated & uploaded on the Institute's website & CPP Portal. Bidders may regularly check with these websites for updates. However, if on the given date, it happens to be a holiday, the same shall be opened on next or working day on the same time at IIM Sirmaur.

The successful bidder(s) shall deposit Rs. 75,000/- (Rupees Seventy-Five Thousand only) as Performance Security to the institute which will be refundable to the bidder without any interest after successful completion of contract.

IIM Sirmaur reserves the right to consider or reject any tender without assigning any reason at any stage of tender process. Canvassing in any form will result in disqualification of the tender.

Terms & Conditions

A. Eligibility Criteria:

The agencies meeting the following eligibility criteria would be considered: -

- 1. A minimum three years of experience as a full INS accredited agency in Central/State Govt./Autonomous bodies/Private Educational Institutions of repute etc.
- 2. The agency should be a registered firm /company incorporated in India.
- A minimum average annual turnover for last three financial years (i.e. 2020-21, 2021-22 & 2022-23) should be of Rupees Thirty Lakhs in print media only.
- 4. The bidder shall not charge for designing translation, creative design etc. activities.
- The bidder should have GST Registration number issued by the Competent Authority in favour of the agency.
- 6. Creativity in development communication should be of high standard befitting the expectations of this Institute of National Importance.
- 7. Should be able to publish the advertisement within 24 hours in respective daily newspapers and within 7- 21 days in employment newspaper.
- 8. The bidder is required to furnish an undertaking on firm's letter head/ affidavit duly attested by the Competent Authority swearing therein that they have not been debarred/blacklisted by any Central & State Government/Autonomous body/PSU etc. from participating in the bidding process.
- 9. Each page of the tender document should be signed and stamped by the bidder.

B. General Conditions:

- 1. The bidding agency should have notable background in the advertising market and an exposure of working with Government Institutions.
- 2. IIM Sirmaur will enter into the contract initially for a period of two years, further extendable for a period of one more year depending on the, same rates, terms & conditions, mutual agreement and satisfactory performance of the agency.

- The Indian Newspaper Society (INS) accredited agencies will only be considered while evaluating the bids.
- 4. Successful bidder(s) shall have to submit a Performance Security deposit of Rs. 75,000/- (Rupees Seventy-Five Thousand only) to IIM Sirmaur.
- 5. The Performance Security deposit will be refunded without any interest to the empaneled agency on successful completion of the contract. If any breach in the contract is found during the tenure, the security deposit will be forfeited.
- 6. IIM Sirmaur shall not make any advance payment to the advertising agency for any of the work assigned. However, the payments shall be released by the IIM Sirmaur against the bills/invoices received from the agency after having completed the job on priority basis within given date & time.
- 7. Preference would be given to those bidders who had worked /are working with IIMs, IITs and NITs, CFTIs, Universities or Educational Institutes of repute.
- 8. The contract will be awarded to those bidders who will be L-1 in the respective individual newspaper's edition as mentioned at Sr. No. 1 to 17 in the Financial Bid BOQ (Annexure-II). However, vendors may be L-1 in more than one cases or all cases.
- 9. The Institute reserves the right to award the contract to various agencies on L-1 basis in each individual newspaper edition based on the least financial quotes.

C. Contract Documents and their interpretations:

- 1. The original agreement shall remain with the Institute while a photocopy thereof may be given to the contractor.
- 2. The several documents forming the contract are to be taken mutually explanatory to one another and in case of any ambiguities or discrepancies, the interpretations of the same shall be communicated in writing by the Institute through its competent authority to the contractor along-with further directions, if any, and the same shall be deemed to be final and binding and shall not be open to question in any court of law.
- 3. If any of the conditions of the tender document is altered/changed/added by the firm, then their tender bids will summarily be rejected and no queries would be entertained.
- 4. Termination of Contract: If any of the terms and conditions provided anywhere in the Tender document/ agreement or any direction issued is not complied with or the contractor is found to have committed any breach thereof, the contract may be

terminated forthwith in addition to the forfeiture of the Security Deposit. The decision of the Competent Authority of IIM Sirmaur will be final in this regard.

5. Arbitration

In the event of any dispute arising between the Contractor and IIM Sirmaur during the currency of the contract or after conclusion thereof, the same shall be settled by Arbitration in accordance with the provisions of the Arbitration and Conciliation Act, 1996 as amended from time to time or any statutory amendments thereof, or any statute enacted for the replacement thereof and shall be referred to the sole arbitrator, to be appointed by the Director, IIM SIRMAUR whose decision in the matter shall be final and legally binding on the parties. In the event of death, refusal, neglect, inability or incapability of the person so appointed to act as an arbitrator, the Director, IIM SIRMAUR may appoint a new Arbitrator. The venue of arbitration shall be the office of the arbitrator or a place suitable to IIM SIRMAUR. Unless otherwise specified in the arbitral award, the cost of such arbitration shall be borne by the Contractor and there will be no objection to this by the contractor.
