If at any stage during the selection process or after the appointment is made, it comes to the notice that the candidate has submitted wrong information and suppressed any factual information as per the requirements of the recruitment advertisement and the Institutional norms in the matter, he/she will be treated and declared as Not Eligible and his/her candidature shall be cancelled.

3. The list of eligible/not eligible candidates is uploaded on the Institute's website for applicants to view their status and convey objections, if any, within 15 days. Days will be counted from the date of uploading of the screening list on the Institute's website. The candidates are to submit his/her objection(s) (if any) by email (attaching all self-attested relevant supporting documents) to [careers@iimsirmaur.ac.in](mailto:careers@iimsirmaur.ac.in) for considerations. The format of the same is at **Annexure- II**. No queries shall be entertained after the allotted time. Further, the final outcome of the considerations shall be informed to the candidates by email.
