2. It is intimated that the eligibility of the candidates at this stage is provisional. Merely being adjudged as eligible at this stage does not confer any right to the candidate of his/her being selected for the post. If at any stage during the selection process or after the appointment is made, it comes the notice that the candidate has submitted wrong information and suppressed any factual information as per the requirements of the recruitment advertisement and the Institutional norms in the matter, he/she will be treated and declared as Not Eligible and his/her candidature shall be cancelled.
