1	Query: Whether the EMD and technical bid documents are to be submitted online or offline?	EMD should be submitted in the form of a demand draft in favor of the Indian Institute of Management Sirmaur payable at Paonta Sahib Distt. Sirmaur H.P 173025. The Scanned copy of the DD (EMD) should be uploaded along with the technical bid cover on the CPP portal. (Refer the page No. 03 of NOTICE INVITING TENDER for EMD Exemption clause)
2	Query: Whether trained executive will be provided by the bidder, at the institute premises, for training and to run hardware and software during the warranty period? (Refer query: Page No. 14 of the NIT under Section-IV in the Scope of work)	The successful bidder will provide trained personnel to train the IIM Sirmaur library employee/staff at the institute premises to enable the staff to run the hardware and software during the warranty period.
3	Query: One of the participating firm proposed to include the following product in the tender: Latest Multi-Purpose Kiosk (with Cart)	After careful consideration with reference to the Institutional requirements, it has been decided not to proceed to add with this proposed product/facility in the scope of work.
4	Query: Whether an MSME entity is exempted from paying EMD or not?	EMD is exempted for MSME/NSIC or as per Govt. of India norms, for which the valid exemption certificate in the relevant category is to be uploaded along with technical bid cover. (Refer the page No. 03 of NOTICE INVITING TENDER for EMD Exemption clause).

Note: Rest of the other terms & conditions of the tender document shall remain same/ unchanged and after the pre-bid meeting dated 09.08.2024, no further query shall be entertained.
