"CORRIGENDUM"

Subject: Corrigendum "regarding the tender for providing printing, photocopying, binding and lamination services at IIM Sirmaur.

With reference to the tender no. IIMS/PUR/Printing photocopying Services/16/ dated 31.05.2024 for providing printing, photocopying, binding and lamination services at IIM Sirmaur. The details of the queries raised by the vendor during pre-bid meeting and the response from the CPC are as follows:-

Sr. No.	Description of Queries	Reponses to the Queries
1	Query: It should be a lockable place / room on the ground floor where we shall install three machines in a centralized unit.	All the three machines have to be installed in a single place. However, the exact place where the machine have to be installed shall be intimated in the award of contract.
2	Specifications of Printing/Photocopy Machine Query: The machines supplied shall be of 75 cpm and should not be older than 2023 with all the specifications mentioned in the tender document.	The vendor has to comply with the technical specification of the machine required as per the tender document. However, the CPM of the machine can be 75 or above and the make and model of the machines should not be older than the year 2023 or prior. The make and model for the year 2023 shall be considered.
3	Specifications of Printing/Photocopy Machine Query: Response time shall be 90% uptime and downtime shall be 24 working hours.	Accepted. However, vendor has to ensure that out of three machine, two should be always in working condition.
4	Annual Turnover Details Query: Instead of FY 2023-24 it should be AY 2023-24 as the balance sheet for FY 2023-24 is not yet finalized.	Accepted.
5	Query: We are registered with MSME / NSIC where we are exempted to pay the EMD. Instead of sending the physical copy, we shall attach the same with the Tender.	MSME/NSIC shall be given exemption regarding submission of EMD amount, only if, the relevant category of the offering services mentioned in the MSME is found.
6	Query: We shall exclusively work for IIM Sirmaur so Rental charges of 5000/- pm may be waived off.	The vendor has to pay a rental charges along with other applicable charges as mentioned in the tender document.

Note: Rest of the other terms & conditions of the tender document shall remain same/ unchanged.
