Item No. 24(g)	Bidders should be regular in filling Income Tax returns. A copy of the Income tax returns filed and audited accounts statement for the last three years (out of last five financial years 2017-18 to 2021-22.
Item No. 24(f)	Average Annual Turnover of the Bidder, pertaining to the last three years (out of last five financial years 2017-18 to 2021-22), should at least Rs. 2.8 Crore. Copies of duly audited Balance Sheet with Profit & Loss accounts are to be submitted for the last three years as above as per Annexure-II. (Technical Bid). The year in which no turnover is shown would also be considered for working out the average.
