Interested agencies may submit their offers on the appropriate application forms of IIM Sirmaur (Annexure-I) alongwith a refundable Earnest Money Deposit of Rs. 10,000/- (Rupees Ten Thousand only), refundable without any interest) to be paid only through Demand Draft drawn in favour of IIM Sirmaur payable at Paonta Sahib, H.P.

The bidders are requested not to submit any document through email, which will result in non-acceptance of the tender.

The received tenders will be opened on 15.07.2021 at 16.00 hours in the Conference Hall of IIM Sirmaur. The successful bidder(s) shall deposit Rs. 25,000/- (Rupees Twenty Five thousand only), refundable without any interest) with the institute as Security Deposit. This security deposit will paid only through Demand Draft in favour of IIM Sirmaur payable at Paonta Sahib, H.P-173025.

Terms & Conditions

A. Eligibility Criteria:

The agencies meeting the following eligibility criteria would be considered:

- 1. A minimum of five years continuous experience as a full INS accredited agency without any break.
- 2. The agency should be a firm / company / registered / incorporated in India.
- 3. A minimum turnover should be of Rupees Ten Lakh in print media only from past 3 years (i.e. 2018-19, 2019-20 and 2020-21).
- 4. Shall not charge for designing translation, creative design etc. activities.
- 5. GST Registration number issued by the Competent Authority in favour of the agency.
- 6. Creativity in development communication should be of high standard befitting the expectations of the Institution of National Importance.
- 7. Should arrange to publish the advertisement on discounted rates in maximum newspapers as desired by the Institute.
- 8. Should be able to publish the advertisement within 24 hours in daily newspapers and within 7-21 days in employment news.
- 9. Each page of the tender document should be signed and stamped by the bidder.

B. General Conditions:

- 1. The bidding agency should have notable background in the advertising market and an exposure of working with Government Institutions.
- 2. The IIM Sirmaur will enter into the contract initially for a period of one year, extendable to a further period (maximum upto 3 years) depending on the mutual agreement of the IIM Sirmaur and the agency with such modifications as may feel necessary and satisfactory performance.
- 3. The Indian Newspaper Society (INS) accredited agencies will only be considered while evaluating the bids.
- 4. Successful bidders shall have to submit a Security deposit of Rs. 25,000/- (Rupees Twenty Five thousand only). This security deposit will submitted only through Demand Draft in favour of IIM Sirmaur payable at Paonta Sahib, H.P.

- 5. The Security deposit will be refunded without any interest to the empanelled agency on successful completion of the contract. If any breach in the contract is found during the tenure, the security deposit will be forfeited.
- 6. IIM Sirmaur shall not make any advance payment to the advertising agency for any of the work assigned. However, the payments shall be released by the IIM Sirmaur against the bills received from the agency after having completed the job on priority basis with in 30-45 days.
- 7. An Earnest Money Deposit of Rs. 10,000/- (Rupees Ten Thousand only, refundable without any interest) to be paid only through **Demand Draft**.
- 8. Preference may be given to them who are working with IIMs, IITs and NITs, Universities or Educational Institutions.
- 9. The contract will be awarded to the concerned vendors who will be L-1 for respective newspapers in Grand Total as mentioned at Sr. No. 1 to 14 in the Financial Bid (Annexure-II). However, vendors may be L-1 in more than one cases or all cases.

C. Contract Documents and their interpretations

- 1. The original agreement shall remain with the Institute while a photocopy thereof may be given to the contractor.
- 2. The several documents forming the contract are to be taken mutually explanatory to one another and in case of any ambiguities or discrepancies, the interpretations of the same shall be communicated in writing by the Institute through its competent authority to the contractor along-with further directions, if any, and the same shall be deemed to be final and binding and shall not be open to question in any court of law.
- 3. If any of the conditions of the tender document is altered/changed/added by the firm, the tender will be summarily rejected.
- 4. The bidder is required to furnish an undertaking / affidavit duly attested by the Competent Authority swearing therein that he has not been blacklisted / disqualified at any time by any Government /authority from participating in the bidding process.
- 5. Termination of Contract: If any of the terms and conditions provided anywhere, in the Tender document/ agreement, or any direction issued is not complied with or the contractor is found to have committed any breach thereof, the contract may be terminated forthwith in addition to the forfeiture of the Security Deposit. The decision of the competent authority of IIM Sirmaur will be final in this regard.

6. Arbitration

In the event of any dispute arising between the Contractor and IIM Sirmaur during the currency

of the contract or after conclusion thereof, the same shall be settled by Arbitration in accordance with the provisions of the Arbitration and Conciliation Act, 1996 as amended from time to time or any statutory amendments thereof, or any statute enacted for the replacement thereof and shall be referred to the sole arbitrator, to be appointed by the Director, IIM SIRMAUR whose decision in the matter shall be final and legally binding on the parties. In the event of death, refusal, neglect, inability or incapability of the person so appointed to act as an arbitrator, the Director, IIM SIRMAUR may appoint a new Arbitrator. The venue of arbitration shall be the office of the arbitrator or a place suitable to IIM SIRMAUR. Unless otherwise specified in the arbitral award, the cost of such arbitration shall be borne by the Contractor and there will be no objection to this by the contractor.

NOTE: The agencies black listed by other government organizations/autonomous bodies will not be considered for empanelment. Tender not received in the prescribed format will be summarily rejected.
