

1. SCOPE OF WORK:

Manufacturing, Supplying, Installation, Testing & Commissioning of Kitchen equipment at Student Mess and other buildings of IIM Sirmaur permanent campus at Dhaulakuan, District Sirmaur (H.P.) as per the specification given in the bid document.

2. EARNEST MONEY DEPOSIT SUBMISSION DETAILS:

- c) In case of successful tenderer, the EMD (if any) may be adjusted towards the Performance guarantee deposit on request.
- d) The amount of EMD (if any) is liable to be forfeited, if the tenderer withdraws from the offer after submission of the tender or after the acceptance of the offer and fails to remit the Performance Guarantee.
- e) No interest will be paid on the EMD (if any) / Performance Guarantee deposited /remitted.

3. <u>OTHER IMPORTANT DOCUMENTS, GENERAL ELIGIBILITY CRITERIA & TECHNICAL CRITERIA:</u>

a) IMPORTANT DOCUMENTS

- i. The receipt of the transactions of tender fee and EMD has to be provided and uploaded along with technical bid cover.
- ii. Copy of OEM certificate, PAN Card, and GST are to be enclosed.

b) **GENERAL ELIGIBILITY CRITERIA**

- i. The Bidder should give self-declaration certificate for acceptance of all terms and conditions of tender documents. A duly completed certificate to this effect is to be submitted as per the Annexure-II.
- ii. The bidder should be neither blacklisted by any government department nor should there be any criminal case registered/pending against the firm or its owner/partners anywhere in India. A duly completed certificate to this effect is to be submitted as per Annexure-III.
- iii. The bidder should attach copy of Work Orders and Completion certificate as documentary evidence. The similar type of works shall mean SITC of kitchen equipment executed in Govt. organizations, institutions like IIT's/IIM's/IIITs/NITs/AIIMS or any other centrally funded institutes during last five years as on August 31, 2023 given below:

Three similar works each of 40% of the estimated cost

OR

Two similar works each of 60% of the estimated cost

OR

One similar work of 80% of the estimated cost

The details of the same along with supporting document are to be submitted as per the Annexure-IV.

- iv. The Average Annual Turnover should not be less than 28 lakhs during each of the previous three financial years (2019-20 to 2021-22) or (2020-21 to 2022-23). Copies of audited balance sheet duly certified by the Statutory Auditor for these three years must be uploaded as per the Annexure-V.
- v. ITR, profit & loss account statements for each of the previous three financial years (2019-20 to 2021-22) or (2020-21 to 2022-23) are to be submitted along with Annexure-V.
- vi. The bidder must submit the banker's Solvency Certificate on the letterhead of the scheduled bank issuing such certificate, sealed in a cover addressed to the Director, IIMS amounting to a minimum of Rs. 22 lakhs. The solvency certificate shall not be more than 6 months old.

Note: The bidder should meet all the above stated conditions for general eligibility.

c) TECHNICAL CRITERIA

- i. Bidders should comply with the specification of the tendered items in all respect, no deviations are acceptable. The bidder is to complete the same in all respect and submit accordingly as per the Annexure-VI. The bidder should meet the entire technical requirement as mentioned in the technical specification for all the equipment.
- ii. The kitchen layout plan is attached as Annexure-X for the reference of the bidders.

4. FINANCIAL BID DETAILS:

Financial bid BoQ is to be submitted after filling all items rates given in the Financial Bid cover on CPP Portal. The financial bid should be uploaded strictly as Annexure-VII available with the tender failing which the offer will be rejected. Kindly quote your price inclusive of all taxes and charges, please note nothing extra shall be paid in the provided Financial Bid BOQ separately in CPP Portal. The Annexure-VII is given for reference to quoting in the Financial Bid BOQ (xlsx. File).

The financial bid consists of **41 items**. The bidders must quote for all these items. In case, a bidder does not quote for any of or all the items in the prescribed format as in FINANCIAL BID BOQ, the financial bid will not be considered.

The bidder should quote prices in financial bid format only in the financial bid cover on CPPP. The offers indicating rates anywhere else shall be liable for rejection.

5. <u>INSTRUCTION FOR REGISTRATION, PREPERATION AND SUBMISSION OF ONLINE BIDS:</u>

- a) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Click here to Enroll" on CPP Portal is free of charge.
- b) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- c) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- d) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sift' / TCS/ nCode/ eMudhra etc.), with their profile.
- e) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- f) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.
- g) This tender document is published on the Central Public Procurement Portal (URL: http://eprocure.gov.in). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

- h) Technical bid should be submitted in PDF format & Financial bid should be submitted in format mentioned in the Financial part.
- i) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF formats. Bid documents may be scanned with 100 dpi with black and white option.
- j) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- k) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.

- I) Kindly upload scanned PDF of all relevant documents in a single PDF file.
- m) Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- n) Bidder should log into the portal well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for non-submission of bids in time or any delay due to other issues.
- o) The technical and financial bids should be submitted online through CPP portal http://eprocure.gov.in/eprocure/app in original. The financial bid should include all the cost and other taxes (As per Central govt. norms) mentioned in the Financial Bid. If there is any separate cost, then that will be not acceptable.

6. **SEARCHING FOR TENDER DOCUMENT**

- a) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID Organization name, location, date, value, etc. There is also an option of advanced search for tenders wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP Portal.
- Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- c) The bidder should make a note of the unique Tender ID assigned to each tender; in case they want to obtain any clarification / help from the Helpdesk.

7. PRE-BID MEETING

a) Bidder's authorized representative(s) shall attend the pre bid meeting online on the prescribed day at the given venue specified in tender. During the prebid meeting, all the technical and commercial issues shall be discussed and concluded to ensure that the bid received subsequent to pre bid meeting shall be without any deviations to terms and conditions. Hence, bidders shall treat the pre bid meeting as utmost important and depute competent & senior person capable of taking on the spot decision to sort out all the technical and commercial issues. However, in case any bidder does not attend the pre bid meeting, it shall be understood that the bidder has a clear understanding of the scope, terms & conditions of the bidding document

and does not have any comments/ deviations to the requirements of the bidding document.

- b) Bidders should send all their queries by email, at least ONE day before prebid meeting, to sc@iimsirmaur.ac.in. The bidders/authorized representatives are advised to attend the pre-bid meeting only. In response to the queries and clarifications during the pre-bid meeting, the institute shall respond as may be deemed necessary through an Addendum/Corrigendum which will be uploaded only on the Institute website & Central Public Procurement Portal. Bidders are advised to periodically check the corresponding websites for any addendum/corrigendum.
- c) Pre-Bid meeting will be held on scheduled date & time indicated in the above table (refer page 2) at IIM Sirmaur campus at Paonta Sahib, Distt. Sirmaur (H.P.) to address the queries of the bidders regarding the tender, if any. Online meeting link will be shared with those who request.
- d) Effort on the part of the bidder or his agent to exercise influence or to pressurize the Institute for his bid shall result in rejection of such bid. Canvassing of any kind is strictly prohibited.

8. **BID VALIDITY PERIOD**

The bid will remain valid for 90 days from the date of opening of financial bid as prescribed by IIM Sirmaur. A bid valid for a shorter period shall be rejected, being non-responsive.

10. **BID OPENING**

- a) Technical Bids will be opened on the scheduled date & time.
- b) Financial Bids of the eligible bidders will be opened on a later date. The date and time for the opening of Financial Bids will be announced later.
- c) Bids will be summarily rejected, if the tender bids submitted other than through online.

11. **BID EVALUATION**

- a) The documents submitted by the bidders as detailed in the checklist (Annexure-XI) will be evaluated in regard to the general and technical eligibility. Bids that meet all the general and technical criteria and technical specifications of all 41 equipment will be considered for further evaluation.
- b) Based on results of the Technical evaluation, IIM Sirmaur evaluates the financial Bid of those Bidders who qualify in the Technical evaluation will be considered. The bidder who quoted the overall lowest bid shall be provisionally selected.

12. **REQUIREMENT FROM SLECTED BIDDER**

The selected bidder will have to provide a proof of procurement of SS 304 by providing unpriced copy of the invoice to the institute and a test certificate from an NABL accredited laboratory. In addition to above, a post-delivery test for SS-304 will also be carried out by the IIM Sirmaur. For such testing a small part of the material supplied shall be sent to a NABL accredited lab at the cost of IIM Sirmaur. Such part of the equipment will have to be replaced by the bidder at his own cost.

13. **PAYMENT TERMS**

a) The running bill payments shall be allowed as follows:

- b) No advance payment will be made in any case. Bills in duplicate should be sent and payment shall be released generally within 30 days, only after it is ensured that condition mentioned in Serial No. 13 (a) meets to entire satisfaction of IIM Sirmaur. In case any product is found defective, or not of desired quality etc., the same should be replaced by the bidder immediately (maximum 15 days) for which no extra payment shall be made.
- c) Deviation in quantity if any with respect to BoQ, shall be paid as per the rate quoted in financial bid.

14. WARRANTY OF QUALITY AND QUANTITY

- a) The successful bidder shall give minimum One-year onsite warranty on supplied items.
- b) The successful bidder shall give warranty that all items are as per specification(s), conforming to the specified design and there are no defects in the process of manufacturing, packaging, transportation and delivery.
- c) The OEMs should provide the specific items as per the list of brands mentioned in the technical specification and BoQ.
- d) Up on receipt of notice from IIM Sirmaur for defective material, the bidder shall within 15 days of receipt of the notice, replace the defective material, free of cost at the destination. The bidder shall take over the defective material at the time of their replacement. No claim whatsoever shall lie on IIM Sirmaur for the replaced goods thereafter. If the bidder fails to replace the defective goods within a reasonable period, IIM Sirmaur may proceed to take such remedial actions as may be necessary, at the bidder's risk and expense.

15. **LIQUIDITY DAMAGES**

In case of delay in supply by the stipulated date, IIM Sirmaur reserves the right of imposing Liquidated Damages (LD) @ 0.5 % per week, subject to maximum 10 % of the total cost of supply order.

16. **PERFORMANCE GUARANTEE**

- a) The successful tender will have to deposit the performance guarantee in the form dBank Guarantee/D.D. at the rate of 10% of the total value of order immediately on receipt of order in favour of IIM Sirmaur, and the same will remain with IIM Sirmaur until expiry of warranty period (1.5 months for Manufacturing, Supplying, installation, testing and commissioning +12 month of warranty) 13.5 months. No interest will be paidby IIM Sirmaur on the deposit.
- b) Performance guarantee will be refunded to the supplier on successful completion of the warranty period.


