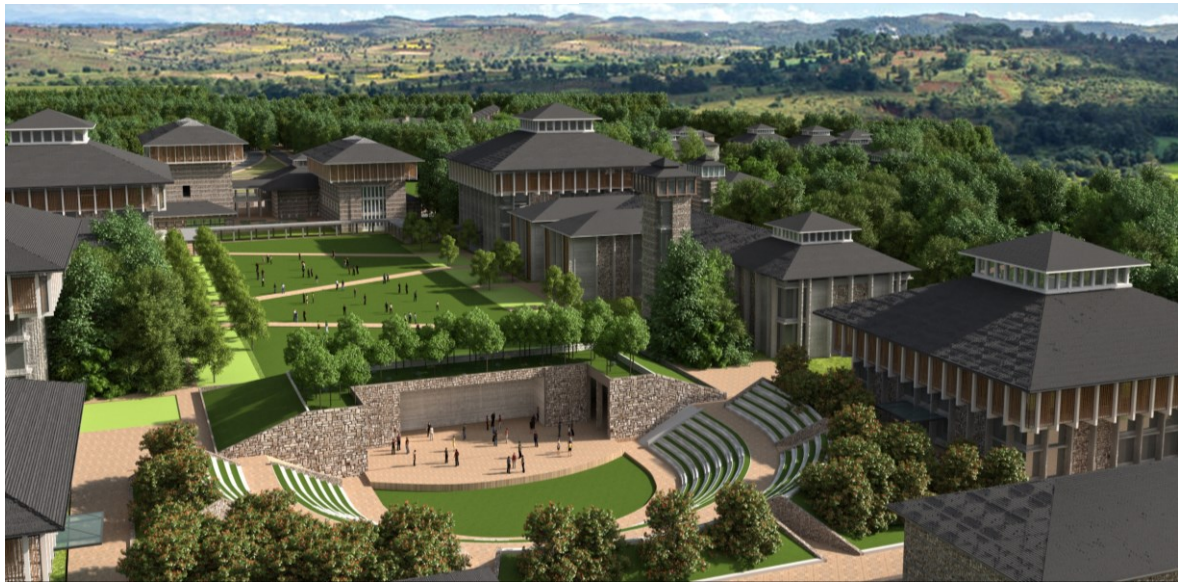

- iv. The applicant shall be an Indian Citizen or an Overseas Citizen of India (OCI).

- Prior administrative experience having held a leadership role
- A good track record of accomplishments in academics, including high quality research publications in reputed journals
- Effective interpersonal and people skills
- Ability to build a high quality faculty team and guide them towards excellence in teaching and research

- Tech savvy and appreciative of use of technology in education
- Experience in managing financial matters and maintaining standards of good governance
- Well networked with a strong industry-connect
- Ability to form strategic partnerships for the advancement of the institute
